Structure, Governance and Management

Constitution

Botanic Gardens Conservation International was established as the Botanic Gardens Conservation Secretariat by IUCN, the World Conservation Union, at the beginning of 1987. In 1990 it became a separate entity and in 1994 changed its name to Botanic Gardens Conservation International.

On 20 February 2003, Botanic Gardens Conservation International (a company limited by guarantee) was incorporated. Charitable status was granted, and with effect from 1 January 2004, all assets, rights and liabilities were transferred from Botanic Gardens Conservation International to this new company. Botanic Gardens Conservation International (the trust) became dormant from this date. Botanic Gardens Conservation International is governed by a memorandum and articles of association and the liability of the members is limited to £10 per member.

Organisational Structure

BGCI is governed by the Board of Trustees that meets quarterly to guide the organisation's work programme and to review management accounts, future development and other organisational matters.

Day to day management of the charity is delegated to the Secretary General, who acts as BGCl's chief executive officer reporting to the Board.

The charity is guided by the International Advisory Council. The Council consists of highly respected leaders of the botanic garden and plant conservation community. They provide technical and scientific guidance and advice on the strategic direction of BGCI.

The charity has a Finance and Audit Committee which meets on a regular basis to review and monitor financial and risk management issues.

Appointment of Trustees

New Trustees (who are also Directors of the company) can be appointed by decision of the majority of the Trustees present and voting at any duly constituted meeting. The total number of Trustees shall be not less than three.

Affiliation

BGCI is a worldwide membership organisation.

BGCI has sister organisations in the United States of America and the Russian Federation:

- BGCI US was established in 1984 and is registered as a Not for Profit Organisation in the State of Massachusetts. It is tax exempt (IRS 0427 30954) and has 501(c) 3 status
- BGCI Russia was established in 2002 and operates as a non-commercial partnership, registered under the laws of the Russian Federation.

Fundraising Standards Board

BGCI is a member of the Fundraising Standards Board, the self-regulatory body for fundraising in the UK, members of which agree to adhere to the highest standard of good practice with their fundraising and to establish a Fundraising Promise incorporating a clear complaints procedure.

Risk Management

A Risk Register which considers the major risks facing the charity, their impact and likelihood of occurrence and identified means of mitigating the risks is in place. The Risk Register is reviewed on an annual basis. The Trustees are satisfied that this process is adequate to assess the major risks to which the charitable company is exposed.

Grants Made for Projects

BGCl's policy on making grants is set out in note 1(f) to the financial statements.

Volunteers and Donated Services and Facilities

Objectives and Activities

Objectives

The objectives of Botanic Gardens Conservation International as set out in the organisation's constitution are as follows:

- To promote for the public benefit the conservation and protection of plant species of the world, in particular the cultivation and maintenance of such plants by Botanic Gardens
- To promote the advancement of education of the public and vocational training and research concerning such plants and their conservation
- To gather and disseminate information on wild plants cultivated or maintained in Botanic Gardens for the purpose of such conservation
- To establish an international network of plant resources via an international database for the purposes of such conservation

Public benefit

When planning its objectives and activities for the year, BGCI has considered the Charity Commission's guidance on public benefit. All of the charitable activities of BGCI focus on plant conservation and are undertaken to further the organisation's charitable purposes for the public benefit.

Trustees' and Directors' Report for the year ended 31 December 2013 (continued)

Main objectives for the year and strategies for achieving them

- To consolidate the development of BGCI from a small largely UK based organisation to an internationally recognised medium sized organisation capable of delivering high quality programmes world-wide
- To identify new medium and long term opportunities to support BGCI, botanic gardens and plant conservation
- To continue to implement activities in accordance with BGCI's Medium Term Plan 2007 2012 while working to develop the next five year plan for the organisation.

Significant Activities, Achievements and Performance

BGCI continued its global programme of plant conservation and education activities in partnership with botanic gardens, networks and other conservation organisations through the provision of advice, information, training and regional workshops. It also worked closely with the Secretariat of the Convention on Biological Diversity (CBD) to promote the implementation of the Global Strategy for Plant Conservation (GSPC). The main countries/areas of activity were: Southeast Asia, Eastern Africa, China, Colombia, Cuba, Mexico, Kyrgyzstan, Georgia, Pakistan, New Zealand, UK and the USA.

The charity continued to attract project funding through trusts and foundations and public bodies. Core income from our botanic garden membership is stable. Donations have increased in 2013 and in particular mention should be made of the support of Peter Olin, and other generous individuals who have donated both for our core activities and to the Sylvia Scholarship Fund.

Preventing Plant Extinctions

In China, Colombia and Cuba, a number of tree species restoration projects, in many cases working closely with the local community, were implemented. With funding from the Fondation Franklinia, exsitu conservation and restoration of tree species included threatened Camellia, Magnolia and Acer species.

In Pakistan, BGCI is continuing a project in collaboration with the Pakistan Botanic Gardens Network Secretariat, Government College University of Lahore aimed at the conservation of threatened native trees in dryland ecosystems of the Indus plains in Pakistan's Punjab province.

In collaboration with the University of Fribourg, BGCI has been developing an action plan for the conservation of *Zelkova* species. This has included geographic and molecular analysis of data from a number of countries within the range of the genus and samples collected from botanic garden collections. 2013 saw the publication of the plan.

The Global Trees Campaign

In association with the University of Bournemouth, efforts are continuing to produce an assessment of the extinction risk of montane tree species in the tropical Andes, including the potential effects of climate change. A PhD student has been recruited to assess the extinction risk of the world's timber tree species, and the societal impacts of their potential extinction. A Red List of Hydrangeas is being produced in association with the Botanical Garden of the University of Ghent, Belgium and work has started on red listing the Betulaceae (birch family).

A revamped website for the Global Trees Campaign (<u>www.globaltrees.org</u>) was launched at the end of 2013. This is an important site for sharing resources and information about the world's threatened tree species.

5th Global Botanic Garden Congress

BGCI held the 5th Global Botanic Garden Congress in Dunedin, New Zealand from 20-26 October 2013 on the theme of 'Celebrating success – the influence and appeal of Botanic Gardens'. The congress was well attended with over 300 delegates from 43 countries. The congress was held in partnership with the 6th Biennial Botanic Gardens of Australia and New Zealand (BGANZ) Congress. It included 17 plenary talks, 12 organised symposia and over 80 contributed papers. The wide range of issues affecting botanic gardens was discussed through a series of presentations and workshops and the future of botanic gardens was the topic of an open forum.

International Plant Sentinel Network

A major new international project aimed at setting up a global network of tree and plant health sentinels was launched at the 5th Global Botanic Gardens Congress. The project, led by the UK's Food and Environment Research Agency (FERA) is coordinated by BGCI and makes use of the over 1 million records in BGCI's PlantSearch database. The International Plant Sentinel Network (IPSN) will develop a community of botanic gardens and arboreta around the world that will use 'sentinel' plants to provide early warning of new and emerging tree and plant pests and diseases.

Ecological Restoration Alliance

In February a seminar was held in London, UK, organised by BGCI as part of the project Enhancing Tree Conservation and Forest Restoration in Africa. The seminar brought together representatives from organisations involved in tree planting and forest restoration in Africa and discussed the potential for using a wider mix of indigenous trees, including endangered species, in tree planting and restoration initiatives. This project contributes to the aims of the Ecological Restoration Alliance of Botanic Gardens which is coordinated by BGCI and which encourages partnerships between large and small botanic gardens to undertake ecological restoration.

A new website for the Ecological Restoration Alliance (<u>www.erabg.org</u>) was launched in October 2013 and provides background information and details of the work of the Alliance. A key feature is an interactive map showing the location of ERABG member projects.

Databases

Development of BGCI's Garden and PlantSearch databases continued. As well as the IUCN Red Lists, PlantSearch is linked to lists of Crop Wild Relatives, the Tree Conservation Database, medicinal plants, CITES listed plants, Tropicos, and a bibliographic database of Plants of the World. Over 3,000 botanic gardens are listed in the GardenSearch database, of which more than 800 have submitted plant lists for PlantSearch, which included over 1.2 million plant records at the end of December 2013.

An advanced search function for GardenSearch which was launched in 2012, enables users to search the database on a wide range of facilities, expertise and resources available in the world's botanic gardens. Results are provided as data files or interactive map points.

Publications

BGCI published its regular serial publications during the year. These consisted of two issues of BGjournal and two issues of Roots. BGjournal was themed on *Building capacity for plant conservation* – the role of botanic gardens (January 2013) and *Botanic Gardens and Food Security* (July 2013). Two issues of Roots were published – 10:1 on *Professional Development for Educators* and 10:2 on *Putting the Audience First:* staying relevant in the race to the future.

Other publications included *Zelkova – an ancient tree : Global status and conservation action.* This report, jointly authored by Joachim Gratzfeld, BGCI and Gregor Kozlowski, University of Fribourg sets of the next steps for the conservation of this relict tree genus and serves as a model to illustrate modern day conservation challenges.

The education department published an executive summary of the detailed evaluation report of the Communities in Nature project.

In a joint initiative with the Council of Europe BGCl published the European Code of Conduct on Invasive Species.

Publications are distributed to BGCI's members and made available for download from the BGCI website.

Website

The BGCI website (www.bgci.org) continues to promote the projects BGCI is implementing and aims to broaden its appeal, ensuring that a wider audience understands our work and to raise awareness of plant conservation. To highlight new information on the website, BGCI also produces and distributes an e-bulletin to on-line subscribers. Four issues of Cultivate were sent out during the year. BGCI also uses Twitter to spread information about its activities and promote plant conservation worldwide.

Policy Frameworks

BGCI continued to achieve global recognition for its international policy work in relation to plant conservation, specifically by providing major support for the Global Partnership for Plant Conservation (GPPC), the global coalition facilitating promotion and implementation of the CBD Global Strategy for Plant Conservation (GSPC). The formation of the GPPC brings together leading agencies involved in plant conservation around the world to work on an ambitious agenda of *in-situ* and *ex-situ* conservation, sustainable use of plant resources, capacity building and education.

BGCI continues to maintain an on-line toolkit housed at the website www.plants2020.net to support national implementation of the GSPC. This is available in the 6 languages of the United Nations (English, Spanish, French, Russian, Arabic and Chinese).

To support national implementation of the GSPC, in 2013 BGCI, in partnership with the Secretariat of the CBD, organised a regional workshop for Southeast Asia which was held in Singapore. This aimed to help participants discuss technical aspects of GSPC implementation as well as understand the linkages between the GSPC and the CBD's Strategic Plan for Biodiversity 2011-2020.

A Southeast Asian plant conservation training course was held in New Zealand prior to the 5th Global Botanic Gardens Congress with support from the Korea Forest Service. This was attended by 15 participants from 7 countries. Further workshops on the GSPC were held during the Congress itself.

Education

BGCI Education had another successful year of supporting education activities in botanic gardens around the world. These are some of the most important events showcasing the range of BGCI Education activities in 2013:

In November 2013 the INQUIRE, EU funded project came to an end. This three year project focused on providing teacher training on inquiry-based science education in 11 European countries. In 2013 BGCI continued to coordinate the project, organised the final Partners' meetings (Trento in September) and two Management Board meetings. BGCI also played a significant role in collecting and collating data from 17 partners for the second interim report and final report to the EU as well as running the INQUIRE website. A milestone event of the project was the INQUIRE conference which

was held at Kew on 9-10th July, 2013. The conference was co-organised by BGCI and KEW and attracted 124 delegates from 13 countries, stimulating discussion and reflections on IBSE.

The Calouste Gulbenkian Foundation continued to fund the project Communities in Nature: Growing the Social Role of Botanic Gardens. In 2013 BGCl published the evaluation report of four UK botanic gardens' community projects showcasing the impact of their work on the community. BGCl ran successfully a day workshop in Prague (May, 2013) for the European Botanic Gardens Consortium to engage them in discussions on how to scale up the Communities in Nature initiative. BGCl Education collected case studies of community projects which are now available on-line through the Community Projects World Map. A panel session was held during BGCl's global conference (October 2013 in Dunedin NZ) which engaged four directors of botanic gardens in debating whether the social role should be a priority for a garden. Various dissemination activities have taken place as part of the efforts to encourage botanic gardens to grow their social role (presentations included conferences in Shanghai, China; Delaware, US; Marrakesh, Morocco and Gothenburg, Sweden). In terms of fundraising BGCl developed a concept note for a project on audience research in botanic gardens.

BGCI collaborated with the Royal Botanic Gardens, Kew, to prepare for running the International Diploma in Botanic Garden Education. 9 participants from different countries have been accepted to attend the five week course which will run in 2014.

BGCI started preparations 9th International Congress on Education in Botanic Gardens, April 26th - May 1st, 2015 in St. Louis, Missouri.

Activities of overseas offices

The China office, based at South China Botanic Garden (SCBG), provides an ongoing coordinating role for our on the ground project work undertaken in partnership with several organisations including the Chinese Academy of Sciences (SCBG, Guangxi Institute of Botany, Xishuangbanna), Yunnan Institute of Environmental Science, Kunming Institute of Botany, Xinjiang Institute of Ecology and Geography, College of Plant Science at Tarim University, and College of Life and Environmental Sciences at Minzu University of China. The office is key to supporting our expanding role in the country.

An updated strategic plan was adopted by the BGCI US Board in February 2012 that provides guidance for work through 2014. With this strategic plan, BGCI US aim to develop and support plant conservation programs that engage BGCI members and partners in the US and North America, as well as build BGCI membership and fundraising opportunities. The office also plays a vital role in connecting BGCI's U.S. members to our global plant conservation network. The office continues to be self-funding and in 2012 and 2013 received additional funding to support BGCI staff time (specifically to support the development of the GardenSearch and PlantSearch databases).

BGCI US continues to partner with the United States Botanic Garden (USBG) to improve the content and quality of data available on plant conservation expertise and collections held by public gardens and conservation communities in the US. This partnership is also helping to build conservation capacity of the USBG, and the US botanic garden community, to more effectively conserve threatened plants. This includes the Care for the Rare project, which has created free, easy-to-use interpretation resources that gardens everywhere can use to clearly communicate conservation stories of threatened plants in their collections. BGCI US is also working with partners in the US and globally to conserve exceptional species (species that can't be seed banked using traditional means).

The US Program Director, Abby Hird, is based at Rancho Santa Ana Botanic Garden in Claremont, California. She is serving a 2-year term as Vice-Chair of the Plant Conservation Professional Section of the American Public Gardens Association; and a 3-year term on the Board of Directors for the Magnolia Society International, providing an opportunity to increase networking and collaboration between BGCI and other partner institutions and botanic gardens in North America.

Financial Review and Reserves

The transactions of the charity are summarised on page 12 of the financial statements, with further details of restricted funds transactions in note 11 on page 19.

The charity in common with many other similar charities receives its donation and grant income with fluctuations in timing and frequency. Payments are dependent on a number of factors such as the preference and cash flow of funders, the completion of work and the submission of reports. In some cases funding is provided in advance of work and in other cases the charity prefinances expenditure.

At the year end net assets and total funds showed a surplus of £201,312 (2012 £101,743) which was made up of restricted funds of £129,429 (2012 £44,237) and unrestricted funds of £71,883 (2012 £57,506). The Board is pleased to note the continued growth of unrestricted funds.

The charity is on course to continue to build up its unrestricted reserve into 2014. The budget for the year to 31 December 2014 is based on a budgeted surplus with a budgeted increase in unrestricted funds of c£95K. Cash flow forecasts show that for the foreseeable future and on a continuing basis the charity is able to meet its liabilities and commitments to funders as they fall due.

Plans for Future Periods

BGCI launched its new five year plan in Dunedin in 2013. The three main area of focus are:-

- Sustaining wild places and plants
- Connecting people with nature
- Finding natural solutions for sustainable livelihoods and well-being

BGCI plans its activities on an annual basis, as agreed by the Board. An ongoing priority is to widen the funding base for the work of BGCI to support an expanded portfolio of conservation and education activities around the world and to secure funding that is unrestricted in its application.

The focus areas for 2014 will be to:

- Develop implementation strategies including a fundraising plan for the activities in the new BGCI 5 year plan.
- Continue to work with the CBD Secretariat on the implementation of the Global Strategy for Plant Conservation carrying out the midterm review of the GSPC, promoting the on-line and multi-lingual versions of the GSPC toolkit and conducting a series of capacity building activities on the GSPC at the regional and national level. We will also develop training materials for botanic gardens on access and benefit sharing to enable then to apply the Nagoya Protocol with confidence.
- Continue to work on growing the social role of Botanic Gardens promoting the activities undertaken to date and seeking funding for further projects.
- Collaborate with the Royal Botanic Gardens, Kew, to run the International Diploma in Botanic Garden Education. 9 participants from different countries have been accepted to attend the five week course which will run in early summer 2014.
- Continue preparations for the 9th International Congress on Education in Botanic Gardens,
 April 26th May 1st, 2015 in St. Louis, Missouri.
- Continue to support threatened species recovery programmes in China, Pakistan, Georgia, Cuba, Jordan and Colombia.
- Continue to support and undertake red-listing of important plant species, including producing a checklist of all tree species and the recruitment of a red list manager.
- Complete a comprehensive review and re-development of BGCI's Darwin Technical Manual for Botanic Gardens.
- Continue the work of establishing the International Plant Sentinel Network.

- Publish two issues each of BGjournal and Roots and further develop e-communications with our membership and the wider community.
- Continue to develop the plant and garden databases, especially in support of work on alien invasive species and ecological restoration.
- Continue to promote the Ecological Restoration Alliance including support for two restoration projects in East Africa.

Directors' and Trustees' responsibilities for financial statements

Charity and company law require the trustees to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the charity and of the surplus or deficit of the charity for that period. They are also responsible for safeguarding the assets of the charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

Independent auditors' report to the members of

We have audited the financial statements of Botanic Gardens Conservation International for the year ended 31 December 2013, which comprise the Statement of Financial Activities, the Balance Sheet and the related notes. These financial statements have been prepared in accordance with the accounting policies set out therein.

This report is made solely to the charitable company's members, as a body, in accordance with Section 235 of the Companies Act 2006. Our audit work has been undertaken so that we might state to the charitable company's members those matters we are required to state to them in an auditor's report and for no other purpose. To the fullest extent permitted by law, we do not accept or assume responsibility to anyone other than the charitable company and its members as a body, for our audit work, for this report, or for the opinions we have formed.

Respective responsibilities of directors and trustees and auditors

The responsibilities of the trustees (who are also the directors of Botanic Gardens Conservation International for the purposes of company law) for preparing the Annual Report and the financial statements in accordance with applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice) and for being satisfied that the financial statements give a true and fair view, are set out in the Statement of Trustees' responsibilities on page 9. The trustees are not required by section 399 of the Companies Act 2006 to prepare group accounts for the year on the grounds that the subsidiary company has been dormant since its incorporation.

Our responsibility is to audit the financial statements in accordance with relevant legal and regulatory requirements, International Standards on Auditing (UK and Ireland) and the Charities Act 2011.

Notes forming part of the financial statements

1 Accounting policies

(a) Accounting convention

These financial statements have been prepared under the historical cost convention, and in accordance with applicable accounting standards, the Companies Act 2006, the Charities Act 2011 and the Charities SORP 2005. The principal accounting policies adopted in the preparation of the financial statements are set out below.

The company has taken advantage of the exemption in Financial Reporting Standard No. 1 from the requirement to produce a cash flow statement on the grounds that it is a small company.

The accounts present information about the company as an individual undertaking and not about its group on the grounds that the subsidiary company has been dormant since incorporation and therefore the trustees are not required by Section 399 of the Companies Act 2006 to prepare group accounts for the year.

The trustees have considered the financial position, forecasts and cash flows of the organisation and are satisfied that it is appropriate to prepare the accounts on a going concern basis.

(b) Depreciation

Computer equipment is depreciated at 25% per annum on a straight-line basis in order to write off the cost of the assets over their estimated useful lives.

(c) Fund accounting

General funds are unrestricted funds which are available for use at the discretion of the trustees in furtherance of the general objectives of the charity and which have not been designated for other purposes.

Restricted funds are funds which are to be used in accordance with specific restrictions imposed by donors or which have been raised by the charity for particular purposes. The aim and use of each restricted fund is set out in note 11 to the financial statements.

(d) Incoming resources

Voluntary income including donations, gifts and legacies and grants that provide core financing or are of general nature are recognised where there is entitlement, certainty of receipt and the amount can be measured with sufficient reliability.

Such income is only deferred when the donor specifies that the grant or donation must only be used in future accounting periods or the donor has imposed conditions which must be met before the charity has unconditional entitlement.

Investment income is recognised on a receivable basis.

Notes forming part of the financial statements (continued)

(e) Resources expended

Expenditure is recognised when a liability is incurred.

- Costs of generating funds are those costs incurred in attracting voluntary income.
- Charitable activities include expenditure associated with the conservation and protection of plant species of the world including research, education and vocational training and the dissemination of information.
- Governance costs include those incurred in the governance of the charity and its assets and are primarily associated with constitutional and statutory requirements.
- Support costs include central functions and have been allocated to activity
 cost categories on a basis consistent with the use of resources, e.g.
 allocating property costs by floor areas, or per capita, staff costs by the time
 spent and other costs by their usage.

(f) Grants

Grants are awarded to members or other conservation organisations, who have agreed a partnership in order to undertake direct, on the ground plant conservation projects that achieve the objectives of BGCI.

(g) Pension costs

The company operates a defined contribution pension scheme. Contributions are charged to the unrestricted fund as they become payable in accordance with the rules of the scheme.

(h) Foreign currency

Transactions in foreign currencies are translated into sterling at the rate of exchange ruling at the date of the transaction. Assets and liabilities at the year end are converted into sterling at the year end rate. Any loss or gain on foreign currency conversion is charged to overhead expenses as incurred.

(i) Volunteers and donated services and facilities

The value of services provided by volunteers is not incorporated into these financial statements, as it is not considered significant.

Where services are provided to the charity as a donation that would normally be purchased from our suppliers, this contribution is included in the financial statements at an estimate based on the value of the contribution to the charity.

(j) Taxation

As a registered charity, the company is exempt from liability to corporation tax on its charitable activities.

(k) Leasing arrangements

Rentals payable under operating leases are charged to the unrestricted reserves on a straight-line basis over the lease term.
